- For Petitioner; Kepilino v. Gonzales, 454 F. 3d I 057 (C.A. 9, 2006): an issue of first impression, addressing whether a state law conviction renders an alien inadmissible under federal immigration law. The Court found Hawaii's statute is overly broad because it criminalizes an isolated act of conduct that does not necessarily involve sexual intercourse. Accordingly, the petition was granted and the IJ's finding was reversed.
